1. Introduction

In addition, this app uses Google Analytics for Firebase for grasping the use situation of the app. Google Analytics for Firebase collects some information to measure and report on user interaction statistics in the app. The information collected may include data related to the device, IP address, activity in the app, App Instance Identifier, advertisement identifiers, Google Inc.'s advertising cookies, and so on.
